Terms and Conditions of this Contract:

**ENTIRE AGREEMENT**: This agreement contains the entire understanding between KEVIN CARDEN and the above named Bride and Groom. It supersedes all prior agreements between the parties in both verbal and written communications. Any changes to this agreement must be in writing, and signed by all parties.

**RESERVATION/DEPOSIT**: A signed contract and deposit are required to reserve the specified coverage. The financial terms of this payment are explained further on.

**PRE-EVENT CONSULTATION**: The parties agree to a pre-event consultation before the event date in order to:

- Finalize actual shooting times, locations, etc.
- List specific photographs desired, along with people's names and titles.
  - An individual other than the Bride or Groom may be designated at the wedding to assist the photographer finding those persons.

**DIGITAL COPYRIGHTS, ARTISTIC PROPERTY**: Final payment for these services determines the release of the photo-disc and prints to the Bride and Groom. No photography will be reproduced in any manner without explicit written permission. There will be a back-up disc kept solely by the photographer.

- The digital images and prints then become the property of the Bride and Groom for their personal use.
- Images may be used on personal websites, local newspapers, etc.
- Acknowledge of the photographer is appreciated, but not required.

**EXHIBITION**: The Bride and Groom grants KEVIN CARDEN to exhibit a few selected images resulting from this assignment as an example of my work, and for the website CARDENSDESIGN.COM.

**LIMITATIONS AND NEGOTIATED TIME**: The photography schedule for the selected locations and times have been discussed by both parties prior to the signing of this contract. It is the goal of the photographer to accomplish all of the goals and wishes of the Bride and Groom in a time manner enjoyed by both parties. However, it is not uncommon for weddings and parties to go on longer than planned. Any services performed after the negotiated time will be charged as overtime, at a rate of \$50.00 per hour. Allowances are made for unusual or catastrophic weather, personal injury, or other uncontrollable situations.

**LIMITS OF LIABILITY**: In the unlikely events that prevent the Bride and Groom from receiving the services included in this agreement, the responsibility and liability is limited to the return of all payments received for the wedding package. These situations include, but are not limited to, the following:

- The photographer becomes injured or too ill to photograph the event.
- The photo-disc, images, or prints are lost, stolen, damaged or destroyed for reasons beyond the photographer's control.

**FEES & FINAL PRODUCTS:**

- The photographer, KEVIN CARDEN, will be paid in full for services specified later in this agreement prior to receiving any photographs, discs, or digital images.
- Payment must be in the form of personal check or cash.
- The processing of the discs should be completed approximately two (2) weeks after the event.
- The processing of the online slideshow should be completed approximately two (2) weeks after the event.
- The processing of photo-books, prints, enlargements, or special requests may take up to six (6) weeks.
- The photographer will deliver the final products as soon as they are completed either by mail, in person, or online.

**MISCELLANEOUS:** Any other items not mentioned in this agreement are to be discussed by the parties prior to the event. Any changes to this agreement can only be made in writing and with the signatures of both parties.
